Refer and win program: Terms & Conditions

- Existing customer data needs to be captured in the LMS for every referral to be eligible for the program
- Customers whose name is in the system are only eligible for the prize every month for the reference
- In case multiple customers have given reference of the same person, whosoever has referred first is eligible for that reference
- Winners for the month shall be announced by 15th of next month

Winner Selection Criteria:

Customers who have referred the maximum number of unique references who get converted will be eligible to get the following prizes:

Gifting is done in 3 categories for the refer and win program across the 118 JCs, which are as below:

- Assured gifts: For all customers who avail Gold Loan during this Refer and Win program period will
 get an assured gift
- **Monthly gift:** Maximum no. of unique references given by existing customers will get monthly gifts basis their ranking. Top 3 customers every month in each JC to win the prize
- Grand prize: At the end of every month, top customer pan India with maximum unique references who are converted to win a bike. 10 zonal winners (top customer in each zone) to get 5 gms. gold coin each

NOTE: JC needs minimum 50 converted customers to be eligible for distributing the prizes

Important:

No winner can win the same prize again. Please look at the example below to understand it correctly. Example 1: Mr. A is the best performer at the end of 1^{st} month in his JC and Zone but not pan India. Mr. A will win Gold Coin, which is the zonal level prize. He will not get mixer-grinder, which is JC level 1^{st} prize. Instead, the 2^{nd} best performer at that JC will get 1^{st} prize.

Example 2: Mr. A is the best performer again in month 2 in his JC, Zone and pan India. Mr. A will win the bike but not gold coin or miser-grinder.

Example 3: Mr. A is the best performer again in month 3 in his JC, Zone and pan India. Mr. A will not be eligible for bike or gold coin, as he has already won it once. He will get mixer-grinder.

• If there is a tie between or amongst customers with respect to maximum conversions, total loan value disbursed shall be considered to declare the winner
